Park

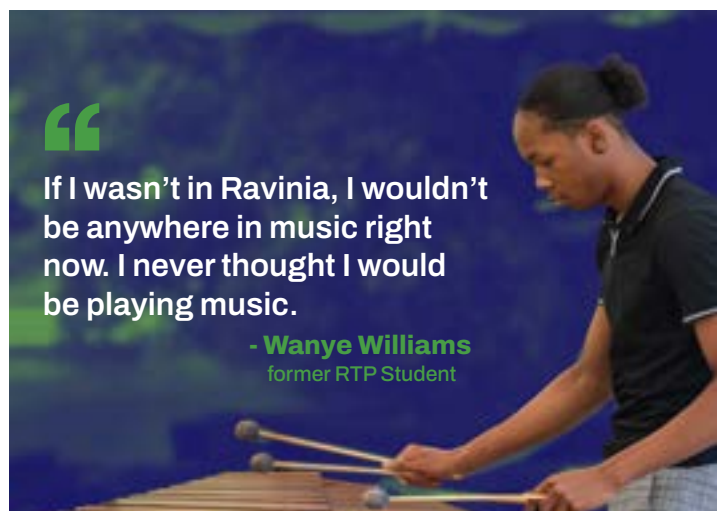
